CONTRACT: this contract for space constitutes a contract between the exhibitor and Niagara Golf Show (hereinafter referred to as show management)

LICENSING TERM: the license given hereunder shall be solely for the use and occupation of the space allocated to the exhibitor. This shall be for the period commencing at the appointed move in time and ending at the appointed move out time including the installation and removal of exhibits.

INSURANCE: full insurance coverage during the entire duration of the exhibition, including move in and move out must be obtained by the exhibitor.

QUALIFICATIONS TO EXHIBIT: retailers, manufacturers, importers and distributors of golf and travel related products and services, including golf courses and travel destinations would be eligible to apply to for exhibit space subject to approval. Show management reserves the right to reserve, decline, or prohibit any exhibit or part of the exhibit, which in its opinion is not suitable in keeping with the character of the exhibition.

LOCATION OF THE EXHIBIT: show management reserves the right to relocate the exhibitor, as it deems necessary to the proper conduct of the exhibition.

SUBLICENSE OF THE SPACE: the exhibitor shall not sublicense, transfer, or apportion any part of the allocated space, shall not exhibit nor permit to be exhibited in the space any merchandise not a part of its own regular products and shall not exhibit any advertising material not directly pertaining to the products exhibited except as specifically approved by the show management.

NON-DELIVERY OF THE BUILDING: show management will not be liable for failure to deliver the space in the event of the building becoming unavailable through fire, act of God, public enemy, strikes the law or any other cause beyond its control.

DAMAGES: shown judgment shall not be liable for any damages whether direct or indirect, general, special, consequential or otherwise to the DAMAGES: Show Management shall not be liable for and damages whether direct or indirect, general special, consequential or otherwise to the exhibitor, its agents and employees or visitors to its exhibit whether occasioned by show management, its officers, agents or employees or by another exhibitor.

EXTENDED MOVE IN OR MOVE OUT: all exhibitors must be completely set up within the surrounding aisles clear two hours prior to the show opening and all materials must be removed from the building by Sunday at 8 PM otherwise you will be subject to a \$500 penalty plus any additional charges. If exhibitor moves out or tears down booth before 5 PM on Sunday \$500 charge will apply.

PAYMENT: full payment of exhibitor space is due upon signing.

In the case the exhibition shall not be held for any reason whatsoever, the license of the space to the exhibitor shall be terminated. In such case, the limit of the claim for damage and for compensation by the exhibitor shall return to the exhibitor in the amount received by the show management from the exhibitor for license of the space, provided that if the exhibition is terminated for any reason, during the term of the license the amount to be refunded to the exhibitor shall be prorated based on the portion of the term expired up to the termination.

EXHIBIT RENTAL INCLUDES: standard drape booth.

All other requirements and furnishings, are the responsibility of the exhibitor. Exhibitors shall be responsible for the setup of their own exhibits.

INTERPRETATION OF REGULATIONS: show management shall have the right to adopt such rules and regulations as to the conduct of the parties prior to, during and after the show as in its discretion it deems to be the best interest of the show. The exhibitor agrees to abide by and be bound by the rules and regulations adopted by the show management as well as all rules and regulations of the general application they may be issued by the building and all bylaws rules, directions, orders and regulations of the regional police, fire department and/or other municipal authorities.
